In addition each candidate may, if he or she so wishes, make an electoral statement (in English, French or Spanish, or in all three languages), using the attached form SU/2018/ELF/5. In this connection it should be mentioned that a candidate may make an electoral statement of not more than 250 words per language in length but must make his or her own arrangements for translation into the other two languages.

All the above documents must reach the office of the Chief Returning Officer <u>together</u> and not later than <u>4 p.m., on Monday, 17 September 2018</u>, in a sealed envelope with the words "Regional Candidature" marked on the outside.

In the event that only one titular candidate employed in the field and one substitute candidate employed at Headquarters are nominated for a particular region, the two will be declared elected for that region. If this is not the case, a vote will have to be taken.\*
