Any member who will be absent from Geneva during the electoral period may authorize by proxy someone to nominate candidates and/or to vote on his or her behalf: this should also be indicated by filling in form SU/2023/EL/4.

Each candidate may, if he or she so wishes, make an electoral statement on form SU/2023/EL/5.

Nominations and certificates of candidature, <u>as well as statements of candidates</u>, must reach the Chief Returning Officer – Mr Samir Koufane – by <u>4.30 p.m. on Friday, 29 September 2023</u>.

These documents can either be forwarded to Mr Koufane (NORMES, Office 6-079), in a closed envelope with the word "nomination" marked on the outside, or sent by email. If the latter is the case, please try to consolidate all the documents into a single email, if possible, and send it directly to him at <u>koufane@ilo.org</u> from your ILO email account.
