<u>Financial Report of the Committee</u> for the period 1 January 2024 au 31 December 2024

- 1. Staff Union members are invited to take note of the following documents attached to this report, covering the above-mentioned period. The Auditor's report is given in a separate document SU/AGM/2025/2/D.3/Add.

- 2. Points for discussion and adoption by the Annual General Meeting:
 - Financial report for the period 1 January 31 December 2024;
 - Redistribution of Reserve Funds.

Comments on selected lines from the financial statements

- 3. <u>Contributions:</u> Contributions collected amounted to approximately CHF 739,000. This represents a significant increase of approximately CHF 54,000 over the budgeted amount, mainly due to the implementation of new, higher salary scales in many locations and regions around the world.
- 4. <u>Turin Centre</u>: This year, the Turin Centre recorded double the amount of staff contributions for 2023 and 2024, which were paid in advance.
- 5. <u>Support staff:</u> This represents the cost of a professional employed on a 50% basis from February to December 2024 in the field of communications.
- 6. <u>Missions (headquarters and field):</u> Includes all transport, accommodation and per diem expenses incurred by all committee members who travel during the year in the course of their duties.

- 7. <u>Africa Regional Meeting</u>: Corresponds to the cost of organising the regional meeting held in Dar es Salaam, which brought together around fifteen members and local representatives from several countries in the region.
- 8. <u>America Regional Meeting</u>: Corresponds to the cost of organising the regional meeting held in San José, which brought together a dozen members and local representatives from several countries in the region.
- 9. <u>Field deductions:</u> Share of local members' contributions deducted and paid to field offices to finance their union activities.
- 10. <u>External collaboration:</u> All assistance and partnership contracts concluded with external parties are included in this item. This includes, in particular, contracts for legal assistance and training.
- 11. <u>Bank charges:</u> Management fees, flat-rate commissions and interest charges levied annually on all the union's current accounts, deposits and investments. Although these bank charges have increased compared to our estimates, they represent 0.53%, i.e. less than 1% of the amount of bank assets and investments.
- 12. <u>Meeting and reception expenses</u>: This item covers the costs of organising meetings or retreats at the headquarters, meals and refreshments related to these events.
- 13. <u>Amount due to the Union:</u> Amount available from the ILO representing membership contributions not yet paid to the Staff Union.
- 14. <u>Difference between income and expenditure (+/-) deficit:</u> The year 2024 recorded a deficit of income compared to expenditure of CHF 1,512.82, corresponding to a loss for the financial year. This loss was charged to the accumulated reserves, specifically to the Staff Union Action Fund.

We saw strong revenue growth during the past year. However, total revenue remained below the amount initially budgeted. The budget proposal for a CHF 90,000 withdrawal from the reserve fund became null and void.

The additional expenses and disbursements for the financial year were absorbed by the available cash assets.
